**Description:** French Pleat Stationary Drapery Panel(s) with Side Return and Separate Traversing Sheer Panel(s) [ADA see additional Optional Rollershade and 2-way draw blackout panels](#)

**Dimensions:** Typical side panel finished width to be 1'-6" wide @ 200% fullness. Center draw Sheer.  
All dimensions and window configurations to be field verified.

**Drapery Fabrication and Hardware Notes:**

1. Refer to 601-A for Roller Shade and ADA Roller Shade Options ([For ADA Rooms see below for additional Optional Traversing Blackout Drapery Fabric](#))
2. All alterations to be submitted to IHG's Design & Plan Review department for written approval prior to manufacturing and purchasing.
3. Quantity: Approximately 1 pair (2 stationary side panels and two sheer panels) per window. ([For ADA rooms optional two 2-way draw blackout panels or rollershade options](#))
4. Panels and Sheers to be 200% fullness; overlock seams with safety stitch and surged, threaded to match predominant color of face fabric pattern.
5. Finished length to be ½" above top of carpet, and/or ½" above top of PTAC unit.
6. French pleat style: 4" double heading, 4" double hem, 1-1/2" double side hem.
7. Hardware: Mount on underside of Conrice Board (Stationary): Provide Kirsch Architrac or Equal. Use ceiling mounted track unless otherwise instructed by IHG.
8. All hardware to be corrosion proof. Drapery fabricator is responsible for the size and quantity of all hardware to be used.
9. Fabric and proposed window treatment applications must be submitted to IHG for review and approval prior to ordering.
10. **Refer to Holiday Inn Window Treatment Preamble for complete specifications.**
11. Drapery to be fan-folded for shipping.
12. All Products must meet or exceed applicable state and local codes.
13. All Products must be contract quality, suitable for commercial use.
14. No products shall infringe on any third party patents, copyrights, trademarks or other intellectual property rights.

**Additional Notes for Sheer Fabrication and Hardware:**

1. Split Draw.
2. Bottom hem to have continuous weight stringer sewn in hem.
3. 250% fullness; overlock seams with safety stitch and surged.
4. Provide off white fiberglass baton sewn into face of reinforced sheer heading no more than 54" A.F.F. Baton to be attached to carrier through corsive proof eyelet and washer to accept baton.
